EUROPEAN COMMUNITIES (MOTOR VEHICLE TYPE APPROVAL) (NO. 2) REGULATIONS, 2002.

The Minister for Enterprise, Trade and Employment has made the above Regulations which will come into effect on 30th December, 2002.

The Regulations give effect in Irish law to three further Directives 2002/51/EC, 2002/78/EC, 2002/80/EC. These Directives have now been incorporated into the EU motor vehicles type approval system. The full list of Directives which are comprehended by that system is included in the Schedule to the Regulations.
