**HADDOCK (FISHERIES MANAGEMENT AND
CONSERVATION) (No. 4) ORDER, 2002.**

This Order allows for the fishing, landing or having on board haddock in ICES area VII (excl VIIa), VIII, IX, X (EC waters) with effect from the 1st day of June, 2002.

From that date, an Irish sea-fishing boat equal to or greater than 55 feet in length and fishing by means of Scottish fly seines, or a person on board such boat, may not have on board or land more than 8 tonnes of Haddock during the period from the 1st day of June, 2002 to the 31st day of July, 2002. All other Irish sea-fishing boats fishing for Haddock or a person on board such boat may not have on board or land more than 4 tonnes of Haddock during this period. It is prohibited to tranship or to engage in transhipment operations of Haddock.

**HAKE (FISHERIES MANAGEMENT AND
CONSERVATION) (No. 4) ORDER, 2002.**

This Order provides for a continuation of the management regime for the hake fishery in Area VI, VII with effect from the 1st day of June, 2002.

From that date, an Irish sea-fishing boat equal to or greater than 55 feet in length and fishing by means of longlines or Scottish fly seines, or a person on board such boat, may not have on board or land more than 5 tonnes of hake during the period from the 1st day of June, 2002 to the 31st day of July, 2002. All other Irish sea-fishing boats fishing for hake by any other method regardless of length, or a person on board such boat, may not have on board or land more than 3 tonnes of hake during this period. It is prohibited to tranship or to engage in transhipment operations of hake.

**MONKFISH (FISHERIES MANAGEMENT AND
CONSERVATION) (No. 8) ORDER, 2002.**

This Order provides for a management regime for the monkfish fishery in Area VII with effect from the 1st day of June, 2002.

From that date, an Irish sea-fishing boat equal to or greater than 55 feet in length, or a person on board such boat, shall not have on board or land more than 4 tonnes of monkfish during the period from the 1st day of June, 2002 to the 30th day of June, 2002. All other Irish sea-fishing boats fishing for monkfish or a person on board such boat, shall not have on board or land more than 2 tonnes of monkfish during this period.

It is prohibited to tranship or to engage in transhipment operations of monkfish.

This Order provides for a management regime for the monkfish fishery in Area Vb (EC waters), VI, XII, XIV with effect from the 1st day of June, 2002.

From that date, an Irish sea-fishing boat equal to or greater than 55 feet in length, or a person on board such boat, may not have on board or land more than 8 tonnes of monkfish during the period from the 1st day of June, 2002 to the 30th day of June, 2002. All other Irish sea-fishing boats fishing for monkfish or a person on board such boat may not have on board or land more than 4 tonnes of monkfish during this period.

It is prohibited to tranship or to engage in transhipment operations of monkfish.

COMMON SOLE (FISHERIES MANAGEMENT AND CONSERVATION) ORDER, 2002.

This Order introduces a new management regime for landings and transshipments of common sole caught by Irish sea fishing boats in ICES Divisions VIIIf and VIIg with effect from the 1st June, 2002.

The Order allows Irish sea-fishing boats to land or tranship common sole caught in ICES Divisions VIIIf and VIIg provided that

boats fishing by means of beam trawls — the common sole may not exceed 0.5% by weight of the total catch of quota species landed or transhipped on any occasion.

boats fishing by means other than beam trawls — the common sole may not exceed 0.5% by weight of the total catch of all quota species landed or transhipped on any occasion.

boats fishing by means of beam trawls — the common sole does not exceed 5% by weight of the total catch of quota species landed or transhipped on any occasion.

boats fishing by means other than beam trawls — the common sole does not exceed 1% by weight of the total catch of all quota species landed or transhipped on any occasion.

From that date, an Irish sea-fishing boat equal to or greater than 55 feet in length, or a person on board such boat, may not have on board or land more than 1 tonne of cod during the period from the 1st day of June, 2002 to the 30th day of June, 2002. All other Irish sea-fishing boats fishing for cod or a person on board such boat may not have on board or land more than 0.75 tonnes of cod during this period.

It is prohibited to tranship or to engage in transhipment operations of cod.
