These Regulations implement Directive 2003/114/EC of the European Parliament and of the Council of 22 December 2003 amending Directive 95/2/EC on food additives other than colours and sweeteners.

EUROPEAN COMMUNITIES (QUALITY AND SAFETY OF HUMAN BLOOD AND BLOOD COMPONENTS) REGULATIONS 2005

*(This note is not part of the Instrument and does not purport to be a legal interpretation).*

These Regulations give effect to Directive 2002/98/EC of the European Parliament and of the Council of 27 January 2003 setting standards of quality and safety for the collection, testing, processing, storage and distribution of human blood and blood components and amending Directive 2001/83/EC, and Commission Directive 2004/33/EC of 22 March 2004 implementing Directive 2002/98/EC as regards certain technical requirements for blood and blood components.

The Regulations may be cited as the European Communities (Quality and Safety of Human Blood and Blood Components) Regulations 2005.

The Regulations apply to the collection and testing of blood and blood components, whatever their intended purpose. The Directive also applies to the processing, storage and distribution of blood and blood components, but only when they are intended to be used for transfusion. The Regulations do not apply to stem cells.

EUROPEAN COMMUNITIES (SAMPLING METHODS AND METHODS OF ANALYSIS FOR THE OFFICIAL CONTROL OF THE LEVELS OF CERTAIN CONTAMINANTS IN FOODSTUFFS) (NO. 2) REGULATIONS, 2005

*(This note is not part of the Instrument and does not purport to be a legal interpretation).*

These Regulations give further effect to Commission Directive 98/53/EC2 of 16 July 1998 laying down the sampling methods and the methods of analysis for the official control of the levels

of certain contaminants in foodstuffs, as amended by Commission Directive 2002/27/EC3 of 13 March 2002 and Commission Directive 2003/121/EC4 of 15 December 2003, Commission Directive 2001/22/EC5 of 8 March 2001 laying down the sampling methods and the methods of analysis for the official control of the levels of lead, cadmium, mercury and 3-MCPD in foodstuffs, Commission Directive 2002/26/EC6 of 13 March 2002 laying down the sampling methods and methods of analysis for the official control of the levels of ochratoxin A in foodstuffs, Commission Directive 2002/69/EC7 of 30 July 2002 laying down the sampling methods and the methods of analysis for the official control of dioxins and the determination of dioxin-like PCBs in foodstuffs, Commission Directive 2003/78/EC8 of 11 August 2003 laying down the sampling methods and the methods of analysis for the official control of the levels of patulin in foodstuffs and Commission Directive 2004/16/EC9 of 12 February 2004 laying down the sampling methods and the methods of analysis for the official control of the levels of tin in canned foods. These Directives were previously transposed by the European Communities (Sampling Methods and Methods of Analysis for the Official Control of the Levels of Certain Contaminants in Foodstuffs) Regulations 2005 (S.I. No. 68 of 2005).

These Regulations also give effect to two new Directives: Commission Directive 2004/43/EC10 of 13 April 2004 amending Directive 98/53/EC2 and Directive 2002/26/EC6 as regards sampling methods and methods of analysis for the official control of the levels of aflatoxin and ochratoxin A in food for infants and young children, and Commission Directive 2004/44/EC11 of 13 April 2004 amending Directive 2002/69/EC7 laying down the sampling methods and the methods of analysis for the official control of dioxins and the determination of dioxin-like PCBs in foodstuffs.

The principal effect of these Regulations is to provide for the methods of sampling, and for the sample preparation and methods of analysis for the official control of the levels of certain contaminants in foodstuffs in accordance with the methods described in the Annexes to the Directives.

These Regulations may be cited as the European Communities (Sampling Methods and Methods of Analysis for the Official Control of the Levels of Certain Contaminants in Foodstuffs) (No. 2) Regulations 2005.

**FORESHORE ACT 1933 (PROHIBITION OF REMOVAL OR DISTURBANCE OF BEACH MATERIAL) (COUNTY KERRY) ORDER 2005**

I, Pat the Cope Gallagher, Minister of State at the Department of Communications, Marine and Natural Resources, being of the opinion that the removal or disturbance of beach material from the particular areas of the seashore specified in the Schedules to the following order—

- (a) has affected or is likely to affect prejudicially any flora or fauna of such areas of seashore,
- (b) has affected or is likely to affect prejudicially amenities or public rights in respect of such areas of seashore and land in the neighbourhood thereof, and
- (c) has caused or is likely to cause injury to such areas of seashore and to any building, wall, pier or other structure on such areas of seashore,

in exercise of the powers conferred on me by section 6(2) (inserted by section 3 of the Foreshore (Amendment) Act 1992 (No. 17 of 1992)) of the Foreshore Act 1933 (No. 12 of 1933), the Communications (Transfer of Departmental Administration and Ministerial Functions) Order 1987 (S.I. No. 91 of 1987) (as adapted by the Marine and Natural Resources (Alteration of Name of Department and Title of Minister) Order 2002 (S.I. No. 307 of 2002)) and the Marine (Delegation of Ministerial Functions) (No. 2) Order 2004 (S.I. No. 703 of 2004), hereby order as follows:

1. (1) This Order may be cited as the Foreshore Act 1933 (Prohibition of Removal or Disturbance of Beach Material) (County Kerry) Order 2005.

(2) This Order comes into operation on 1 July 2005.

2. The removal or disturbance by any person of beach material of any kind, other than seaweed, from or in the particular areas of seashore specified in the Schedules to this Order is prohibited.

**Schedule 1**

All that area of seashore, within the estuary of the Cashen River, which is in and adjacent to the townlands of Knoppoge, Derryra Beg, Derryra More, Knoppoge North, Ayle, Derryco, Mwееvoo, Dunferris, Ragoonagh, Ahimma and Balleagh in the county of Kerry, which area extends—

- (a) from the point where the boundaries of the townlands of Cloghane and Knoppoge meet the seashore on the south side of that river to the Ferry Bridge, and
- (b) from the Ferry Bridge to Balleagh House on the north side of that river.

**Schedule 2**
