**HEPATITIS C COMPENSATION TRIBUNAL
 (INSURANCE SCHEME FOR RELEVANT CLAIMANTS)
 (AMENDMENT) REGULATIONS 2008.**

These Regulations are made under section 7 of the Hepatitis C Compensation Tribunal Act 1997 (No. 34 of 1997) (as amended by section 3 of the Hepatitis C Compensation Tribunal (Amendment) Act 2006 (No. 22 of 2006)).

These Regulations amend Regulation 9(1) of the Hepatitis C Compensation Tribunal (Insurance Scheme for Relevant Claimants) Regulations 2007 (No. 31 of 2007) to provide clarification on the evidence to be provided in respect of the verification of annual earned income.

These Regulations may be cited as the Hepatitis C Compensation Tribunal (Insurance Scheme for Relevant Claimants) (Amendment) Regulations 2008.
